MINUTES of a MEETING of SHOREHAM PARISH COUNCIL

Shoreham Village Hall 6 April from 7:30pm

Present: Cllrs B Jeffery (in the Chair), R Blamey, A Hibbins, N Powell and M Sheward

Also Present: 8 members of the public (in part)

The following comments were made:

• The safety barrier is out on the road by the King's Head and there is no foot path on other side.

- There is a water leak in Mill Lane and by Orchard House for which Thames Water is responsible.
- Notice Boards residents commented about the notice boards in the village and Members agreed that the Parish Council would maintain the official notice board in the village on the wall of the Village Hall.
- Members agreed that CIIr Blamey should represent the Parish Council on a Committee to discuss health & safety aspects of the village hall.

- 2. There were no disclosures of interest.
- 3. Members resolved to agree the minutes of the meeting held on Wednesday 2 March 2022 (copies previously distributed).

Cllrs Edwards-Winser gave a report and a copy is attached at Appendix A.

Cllr Gough made the following comments:

- A225 average speed data due to be released very soon.
- Mill Lane/High Street Thames Water leak. The pothole was repaired on 28 March but due to flooding it has come out again. KCC are pushing Thames Water with regard to both leaks.
- Lord Debem, Chair of Government Climate Change Committee visited KCC and spent time at Preston Farm.
- KCC had a large number of matches for homes for Ukraine Scheme. There are many challenges around safeguarding in implementing the scheme.
- KCC is consulting on a £2million reduction in bus services. The Government launched the National Bus Strategy and KCC completed it with a funding request and heard nothing. Cllr Gough advised that yesterday KCC were advised that they will get £35 million funding but do not know what the limits of the funding will be. There is also a reduction in usage.
- Cllr Gough also commented on the issues over the M20 and Operation Brock.
- Cllr N Powell asked about putting power lines under line following numerous power outages. Cllr Gough agreed to get further information on that item.
